

GET OUT THE FLOAT 2025

PARENTAL PERMISSION AND LIABILITY RELEASE FORM

This is an agreement between Get Out The Float, LLC, and you, the parent or legal guardian of a minor attending Get Out the Float 2025. Minors may attend Get Out the Float, provided we have a completed Release Form on file.

For minors 15 years old or younger, Get Out the Float requires that a parent, legal guardian or designated adult accompanies the minor at all times during the convention. For minors 16 or 17 years old, Get Out the Float requires that a parent, legal guardian or designated adult is within the vicinity while the minor is attending. The vicinity is defined as the city limits of Seaside, Oregon.

Get Out the Float uses the age of the attendee of the first convention day to determine policies; for example, if the minor is 15 years old on February 6, 2025 and turns 16 years old on February 7, 2025, they will be considered to be 15 years old for the full duration of the convention.

By signing below:

1. You warrant that you are the minor's parent or legal guardian, and have the legal authority to enter this agreement regarding your minor child;
2. You give permission for your minor child to attend Get Out the Float 2025;
3. You agree that Get Out the Float, LLC and Get Out the Float organizers have no responsibility whatsoever to monitor or supervise the minor at any time during Get Out the Float 2025, and you agree to not hold Get Out the Float 2025 and/or its organizers responsible for any wrongdoing, claims, demands, or liability;
4. In the unfortunate event of any damages caused by your minor child at any time during their attendance at Get Out the Float 2025, you accept financial responsibility, and agree to fully indemnify and hold harmless Get Out the Float, LLC for those damages.

This form must be submitted upon registration at Get Out the Float 2025 before the minor may pick up their badge. The form may be signed in person during badge pickup, or it may be notarized and digitally sent to our email at: registration@getoutthefloat.com
